1. This Invitation for Bids follows the General Procurement Notice (GPN) for this project that appeared in UNDB online of **18 October 2019** and on the African Development Bank Group's Internet Website.
2. The Federal Government of Somalia has received Financing from the African Development Bank towards the cost of Road Infrastructure Programme, Somalia. It is intended that part of the proceeds of this grant will be applied to eligible payments under the contract for rehabilitation and reconstruction of Lot2 Section1 Galkayo-Xarfo road (67km) to asphalt concrete standard.
3. The Ministry of Public Works, Reconstruction & Housing now invites sealed bids from eligible bidders for the execution of the works involving rehabilitation and reconstruction of Lot2 Section1 Galkayo-Xarfo road (67km) to asphalt concrete standard, 6.5m carriageway, 1.25m shoulders, construction of other ancillary works. The flexible pavement structure comprises asphalt concrete surfacing (wearing course), crushed stone base, gravel sub-base. The shoulders shall be double surface seal.

Approximate quantities for key items in the Bill of Quantities are set out below:

• Excavation and fill	130,050 m <sup>3</sup>
• Gravel sub-base	69,135 m <sup>3</sup>
• Crushed stone base	54,040 m <sup>3</sup>
• Asphalt concrete wearing course	535,500 m <sup>2</sup>
• Double surface seal	167,860 m <sup>2</sup>

The road is located in Puntland State, Somalia and is part of the North-South road corridor. The construction period is 12 months (including mobilisation) and this is followed by 12months (365 days) Defects Notification Period (DNP).

A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written application to the above and upon payment of a non-refundable fee of **USD\$250 (two hundred and fifty US Dollars)**. The method of payment will be through the Ministry of Finance payment system. The bidding documents will be issued to the bidder (in hard copy and electronic copy) upon presenting proof of payment. (**NB:** The essence of issuing electronic copy of the bidding documents to Bidders is to enable Bidders to complete the various Forms in the Standard Bidding Document electronically and have them submitted in hard copies.)
6. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement of Large Works (Without Prequalification).

Bids must be delivered (**in hard copies**) to the above office on or before **1:30pm Mogadishu time on 03 October 2024** and must be accompanied by a bid security of **USD\$250,000 (two hundred fifty thousand US Dollars)**. For Priced Bill of Quantities, Bidders may include an electronic copy in addition to the mandatory hard copy to facilitate evaluation of the Priced Bill of Quantities.
