This request for expression of interest follows the General Procurement Notice for this project that appeared in United Nations Development Business (UNDB) online on **18 October 2019** and on the African Development Bank Group's Internet Website on **18 October 2019**.

The Government of Somalia has received financing from the African Development Bank and the European Union towards the cost of Somalia Road Infrastructure Programme and intends to apply part of proceeds for these grants to make eligible payments under the contract for **Consultancy Services for Construction Supervision of rehabilitation and reconstruction of Lot 1 Section 2 Dhusamareb-Qaridhi Road (60km)**.

The services include: (i) To review the design and rescope works to accommodate any findings during implementation and ensure that the road is rehabilitated and reconstructed in accordance with the General and Particular Conditions of Contract, the Technical Specifications and Engineering Drawings. (ii) To optimize the use of available material resources to minimize costs to the Employer or to maximize the quality of Works or to expedite construction, and (iii) To ensure that the road is constructed within the Contract Price and Time allowed for Completion under the Contract. The contract period is 24 months comprising of 12 months Construction Period, and 12 months Defects Notification Period (DNP).

The Ministry of Public Works Reconstruction and Housing, Somalia now invites eligible consulting firms to indicate their interest in providing these services. Interested consulting firms

must provide information indicating that they are qualified to perform the services (**brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, evidence from Clients of similar assignments undertaken, etc.**). Consultants may constitute joint ventures/associate to enhance their chances of qualification.

Eligibility criteria, the establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank's "***Procurement Policy for Bank Group Funded Operations***" dated October 2015, which is available on the Bank's website at <http://www.afdb.org>. The Client is under no obligation to shortlist any consultant who expresses interest.
