The Federal Government of Somalia has received financing from the African Development Bank (AfDB) and the European Union (EU) toward the cost of the Roads Infrastructure Programme Somalia (RIP-SO), and intends to apply part of the proceeds of this grant to payments under the contract for the provision of Consultancy Services for Capacity-Building Trainings under RIP-SO.

The objective of this consultancy is to design, deliver, and report on four (4) capacity-building trainings for Federal and State-level institutions involved in the road sector. The consultancy firm will be responsible for provision of the training methodology and training program, training materials and equipment, logistics, venues hire and catering services and post-training reporting. The training modules include;

- Guidelines for Gender Mainstreaming in Infrastructure and Leadership Training.
- Community Engagement in Road Sector Development.
- Guidelines for Mainstreaming Environmental and Social Risk Management Training.
- Road Data Collection and Analysis for the Federal Government of Somalia and Ministry of Public Works and Housing Teams.

The method of selection shall be Quality Cost Based Selection (QCBS).

The contract period is one year.

Ministry of Public Works now invites eligible Consultancy firms to indicate their interest in providing the above services. Interested consulting firms must provide information indicating that they are qualified to perform the services (**Description of similar assignments**, experience in

similar conditions in the region, Availability of appropriate skills of certified trainers with facilitators with proven expertise in their respective thematic areas, ability to provide certifications upon completion of each training to trainees. Submit brochures, evidence from Clients of similar assignments undertaken, etc.).

Eligibility criteria, establishment of the shortlist, and the selection procedure shall be in accordance with the African Development Bank's "*Procurement Policy for Bank Group Funded Operations" dated October 2015*, which is available on the Bank's website at http://www.afdb.org. MPWR&H is under no obligation to shortlist any consultant who expresses interest.
